The firm has grown considerably since Alison and I founded it, and although I am immensely proud of what it has become, I also feel we have only achieved a fraction of what the future holds.



A Legal Update

Earlier this year the English Court of Appeal upheld the detention of the superyacht "Phi".

The Court of Appeal considered the detention of the luxury motor yacht "Phi" owned by a Russian national, under the Russia (Sanctions) (EU Exit) Regulations 2019.

The Court dismissed the appeal challenging the detention of 58.5- metre Phi, which was arrested in 2022, on the basis of recently-introduced sanctions law following Russia's invasion of Ukraine. The appeal was based on the fact the yacht's owner, a Russian national, has never appeared on any sanctions list.

The ruling held that the superyacht had not been detained for an improper purpose considering the owner's residency in Russia

and "economic activities", agreeing with the Respondent's claim that "directly or indirectly, a [Russian of significant wealth] is likely to have benefitted from the Russian regime."

Since the English decision, the General Court in Brussels handed down a judgment which seemingly softened the interpretation of the EU's approach to non-sanctioned Russian citizens.

Two Russian citizens were removed from the European list of sanctioned individuals because it had not been proved that they were directly involved in efforts to undermine or threaten the territorial integrity, sovereignty and independence of Ukraine.

More than 1,700 Russian Individuals and 400 entities have been subject to trade sanctions since 2014. In the case brought by Petr Aven and Mikhail Fridman, "a degree of proximity" to Mr. Putin was not enough to show they benefited from the Russian regime.

It will be interesting to see how this judgment affects the release of seized assets in the future.



A Few Things We've Learned...

Superyachts: Greek e-Charter

The Greek government has recently launched the "e-Charter Permission" system. This system allows non-EU-flagged vessels to charter in Greek national waters, which was previously disallowed. Before that foreign-flagged yachts were required to be owned by a company with a Greek branch of business to qualify for a Greek charter license. This new system simplifies the process and opens up charter opportunities for non-EU vessels.

This is excellent news for those many clients who love to cruise in Greece!

Aviation: The Netherlands Registry

Aircraft mortgages in the Netherlands are registered on a public register operated by the "Kadaster." This separate register is distinct from the Dutch Civil Aviation aircraft register. To establish a mortgage, a notarial deed is required, followed by registration with the Kadaster. Unfortunately, the Kadaster register is not searchable online. So if you are buying or selling a Dutch aircraft, full due diligence is required!

Additionally, the Netherlands has not ratified the Cape Town Convention for the mainland Netherlands (only for Aruba, Curacao, Sint Maarten, and Caribbean Netherlands). Consequently, a mortgage granted by a Dutch owner for a Dutch-registered aircraft lacks the necessary "connecting factor" to be eligible for registration as an "International Interest" on the International Register. In cases where a seller is unaware of relevant finance arrangements or procedural mistakes have occurred (such as unpaid mortgages), the owner must request the discharge of a mortgage registered on the Kadaster.

The Dutch court confirms interest holders' consent to the discharge, and upon authorization, the Kadaster register can perform the discharge. The confirmation of discharge is then sent to the Dutch national register for the aircraft to be de-registered.
